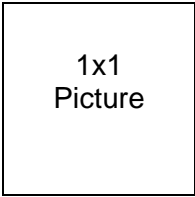

DEALERSHIP AGREEMENT

This AGREEMENT, made this ____ day of _____, 2007 at _____, Philippines by and between **RED LOGO LIFESTYLE, INC.**, a corporation duly organized and existing under the laws of the Republic of the Philippines with principal offices at 880 A.S. Fortuna St., Banilad, Mandaue City, Cebu, Philippines (hereinafter known as “the Company”) and _____, Filipino, of legal age and a resident of _____ (hereinafter known as “the Dealer”).

Witnesseth that:

1. The Company allows the Dealers to purchase the products of the Company at wholesale, subject to the Company’s sales, compensation and credit policies.
2. The Dealer is an independent retailer/dealer/businessman. The Dealer shall obtain all permits and licenses required to conduct his/her business and comply with applicable laws including payment of taxes.
3. The Dealer agrees to sell the Company’s products at the retail prices stated in the Company’s catalogue.
4. The Dealer shall pay all his/her purchases in accordance with the Company’s policies without need of demand.
5. The Dealer agrees not to use any of the trademarks or trade names owned by the Company or its affiliates without prior written consent from duly authorized officer of the Company.
6. The Dealer abides by the Code of Conduct, policies, rules and regulations issued by the Company. Serious violation of which may result to termination of this Agreement.
7. The Dealer understand that the Company may change its sales, delivery, incentives, compensation and credit policies at any time and in any manner and may diminish or cancel present benefits effective without need of individual notice.
8. This Agreement, does not make the Dealer an employee of the Company. Dealer is not authorized to bind the Company in any contract with other parties.
9. The Company or the Dealer can terminate this Agreement, with or without cause, at any time upon notice to the other. Upon termination, all accounts of the Dealer shall become immediately due and demandable.
10. In case of litigation arising directly or indirectly from this Agreement, the venue shall be the proper courts in Mandaue City, Cebu, Philippines or elsewhere at the option of the Company.
